## Training Announcement

### Inland Oil Spill Response for DOI – CSP3129

#### Course Description

This course will be presented by a group of experienced instructors led by a team from Research Planning, Inc. ([www.researchplanning.com](http://www.researchplanning.com)), including Jacqueline Michel, Scott Zengel, and Chris Boring. RPI is a distinguished leader in oil spill preparedness, response, assessment, and training. This course will cover the many aspects of oil spill response from the DOI perspective, such as what roles DOI staff have within the Unified Command, evaluating and selecting appropriate habitat protection and cleanup methods and cleanup endpoints, being a member of a SCAT team, emergency consultation, and juggling the roles of response and natural resource damage assessment. Oil fate, transport, and effects in inland environments will be covered through basic principles as well as case histories. A drill exercise will be used to apply many of these topics during realistic scenarios.

- Understand the roles and responsibilities of DOI Bureau personnel in spill response and how DOI coordinates during an incident.
- Receive Hazwoper 8-hr Refresher certification.
- Know practical NRDAR response coordination during an incident.
- Demonstrate all knowledge & skills necessary to be performed by DOI Bureau personnel before, during and after an inland spill incident.
- In a mock ICS drill exercise, handle all aspects of coordination, communication, and decision making using guidelines and authorities of ICS; work effectively with EPA, Tribes, and State partners.
