GUIDING AUTHORITIES AND REGULATIONS

NCP (1968 et seq.)

CERCLA (1980)

Executive Order 12580 (1987) Identify legal responsibilities as the "removal response authority" for HAZMAT "releases or threatened releases" when an Army facility is the sole source of the releases into the community or when the release remains on the facility.

AR & DA PAM 525-27 **HSPDs**

Provides guidance to the Army (through DoD) of its emergency management roles and responsibilities as a department within the Federal government.







ARMY OSC REQUIREMENTS

- Army environmental and emergency preparedness program regulations require that their installations, through the garrison commander, appoint a qualified On-Scene Coordinator (OSC) to execute responsibilities under 40CFR300 (National Contingency Plan)
- As a primary (lead) agency under the NCP, the "Army" defines what qualified means for their purposes, though qualification infers some formal training program.
- The Army Material Command uses this course to provide training to appointed OSCs for their installations.

HYPOTHETICAL MODEL FOR THE ARMY'S FEDERAL OSC ROLE




COMPLEX COORDINATION ENVIRONMENT (CSEPP EXAMPLE)

COURSE PURPOSE AND SCOPE

PURPOSE:

To provide leaders and managers at Army installations with the basic knowledge and skills needed for performing the functions of a federal on-scene coordinator (OSC) in the event of the release of a hazardous substance.

SCOPE:

- For Army personnel and Department of the Army civilians who are assigned or will be assigned to positions that may cause them to act as an OSC.
- Course emphasizes critical OSC duties (e.g., inter-agency coordination, risk management, risk communications, response organization, and media relations) in the context of a hazardous substance release.


