11:00 am Ecology Strike Team – Mike Coffey, US FWS Some States, Areas, or Sub Areas may want to form interagency cooperatives, strike teams, or eco strike teams to help rapidly fulfill the immediate and diverse needs of a complex spill response either large or small. An eco-strike team may be as simple as a group of spill responders with specialized skills and knowledge about habitats and species that are generally ready and available to deploy and as a group do some planning and training. The benefits of an eco-strike team include expertise and materials for spill response tactics to minimize or avoid impacts from the response to natural resources and responding to wildlife at risk or oiled wildlife especially for complex or sensitive environmental situations. The Subarea and Area spill response contingency planning meetings and exercises are a forum to discuss and provide training for strike teams. This is also an opportunity to develop response priorities and strategies for along interstate boundaries, distant edges or borders of response Sub Areas, Areas, and Regions where there may be confusion by overlapping jurisdictions or areas of responsibility.
