

- EGLE budget for FY24 includes requirement that the department notify relevant elected officials whenever there is an event of "significance" in their area.
- Department policy making it mandatory for staff to report pollution emergencies to the department.
- New Director, Phil Roos was named in July.

Motor Vessel/ Manitowoc Diesel Release
Manistee, MI (Lake Michigan)
US Coast Guard, Sector Lake Michigan
August 2, 2023 – August 4, 2023
Roughly 1,000 gallons of diesel.
Bolt sticking out from a dock in Manistee, MI punctured a 1" hole through the hull and starboard fuel tank of the vessel. Full overview tomorrow from Coast Guard.
 On-water vessel response plan activation. Oil in water reconnaissance Coast Guard Overflights Shoreline Assessment Collection and recovery/ agitation and mixing
US Coast Guard, EGLE, Manistee County Sheriff and Emergency Management, City of Manistee
Virtual Unified Command works well for localized incidents, but still need local presence for field work and media inquires.

Name of Incident	Tissue Depot – Cheboygan Paper Mill Warehouse Fire
Location	Cheboygan, MI
Date	September 13, 2023
Type and Amount of Product Spilled	Recycled mixed-use plastic pieces and coal fly ash piles.
Cause of Spill	Fire in a storage warehouse across the street from a paper mill. Scrap plastic (100 tons) that was stripped from cardboard was stored in the warehouse along with coal ash. Building caught fire and burnt the plastic piles.
Key Operational Activities	 Air monitoring the large black plume. Fire water run-off control. Joint Information System and public messaging (shelter in place, press briefing).
Agencies Involved	EPA, EGLE, US Coast Guard, MI DHHS, Cheboygan County Emergency Management, City of Cheboygan.
Major Lessons Learned	Timely deployment and limited air monitoring resources becoming more of an issue as capabilities shift due to funding shortages locally and at the state level.






