The National Historic Preservation Act Section 106

- Requires consideration of Historic Properties
- Informed Decision Making Through Consultation
- State Historic Preservation Office (SHPO)
- Tribes
- Public
- Slow and Iterative
- Roughly analogous to ESA

The 1997 Programmatic Agreement (97 PA)

- Alternate Way to Comply with Section 106
- Identifies the Historic Property Specialist
- Implementation Guidance Under Development
- The Response is the Undertaking!!

The Historic Property Specialist

- Sits in the Environmental Unit or Planning Section
- Liaison with Operations
- Reports to the FOSC
- Should not be hired by RP

The Historic Property Specialist -Activations

- Deep Water Horizon
 - Tribal consultation
 - Review of Operations plans
- Huntington Beach Spill (2021)
 - Historic Wharf
 - Initiated consultation with SHPOs
 - Tribal monitors
 - Unanticipated discovery protocol
- American Challenger (2021)
 - Coordination with Tribes
 - Avoidance of sensitive sites
